**Foreword**

Article 12, para. 12.1 provides that a party intending to participate in the market must submit to GME: a market participation application, in the format of Annex 1 to the Integrated Text of the Electricity Market Rules (hereafter “ME Rules”), together with the documentation indicated in Article 13 thereof; and a market participation agreement, in the format of Annex 2 to the ME Rules.

Article 14, para. 14.1 provides that, after verifying the applicant’s fulfilment of the requirements and the validity of the documentation submitted in view of participating in the market, GME shall notify the applicant of its admission or of the rejection of its application.

Article 14, para. 14.4 provides that, where the documentation submitted in view of participating the market is incomplete or irregular, GME shall – under the modalities and within the time limits defined in the Technical Rules – communicate to the applicant the steps necessary to complete or regularise the same documentation, as well as the date by which it shall do so.

Article 20, para. 20.1 provides that, for the purposes of exclusion from the market, Market Participants shall – under the modalities and within the time limits defined in the Technical Rules – provide GME with an appropriate written request.

**1. Modalities and time limits of GME’s notifications**

GME will notify by registered letter with return receipt, or by certified e-mail:

- the admission of the applicant to the market or the rejection of its market participation application (article 14, para. 14.1);
- in the case of incomplete or irregular documentation, the steps necessary to complete or regularise such documentation, as well as the time limit by which the applicant shall do so (article 14, para. 14.4).

**2. Modalities and time limits of the applicant’s/Market Participant’s notifications about admission/exclusion to/from the market**

A party applying for participation in/exclusion from the market must send the following documents to GME by post, courier or certified e-mail:

- original copy of the market participation application, in the format of Annex 1 to the ME Rules, signed by the individual or by the legal representative of the company (article 12, para. 12.1 a));
- original copy of the documentation referred to in article 13 of the ME Rules, signed by the individual or by the legal representative of the company (article 12, para. 12.1 a));
- original copy of the market participation agreement, in the format of Annex 2 to the ME Rules, signed by the individual or by the legal representative of the company (article 12, para. 12.1 b));
- original copy of the request for exclusion from the market, signed by the individual or by the legal representative of the company (article 20, para. 20.1).
